The concept of digitalization is the process of introducing and enhancing digital technologies, within the context of business and value creation models. It tends to describe the use of innovative technologies that can dramatically change a firm's performance, operational efficiency and offerings [4].

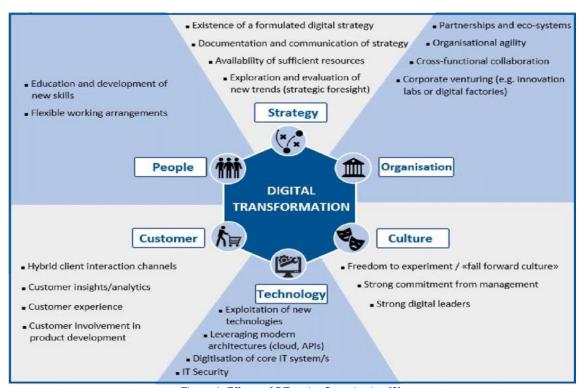


Figure 1: Effects of DT to the Organization [6].

In general, DT describes the shift from traditional (often physical) creation and delivery of customer value, including the operational procedures related to this, into the

massive use of digital technologies which enhance or replace the traditional product with smart, connected product [5]. Effective adoption and use of transformational technologies requires an organization to have a flexible IT infrastructure that cause significant effects on productivity in all ramifications, which create big potentials in the development of industries and economies. DT generally affects the whole/part of the organizational structure, its Strategies, Technology, customers, People and culture that forms the Enterprise as illustrated in the Figure 1.

Although the volume of research on DT and its effects on businesses in industrialized nations is expanding, there is a large knowledge vacuum regarding the unique situation of SMEs in Nigeria [10]. There is a dearth of thorough study that addresses the particular difficulties and opportunities faced by Nigerian SMEs in embracing and utilizing the potential of IT for their development as a result of existing studies predominate focus on DT in large enterprises. Coupled with the new global project – "Going Digital: Making the Transformation Work for Growth and Well-being" launched by the organisation of economic cooperation and development (OECD) in an increasingly digital and data-driven" world [11].

# 2. Enhancing Nigerian SME's through DT

In Nigeria, the adoption of mobile phones, social media and internet technologies has reached new levels in recent years, with internet penetration increasing at about 10% every year, and active GSM subscriber lines growing from 145 million in 2017 to 184 million at the end of 2019 [12]. This makes the digitization and transformation of the business model crucial for building a competitive advantage and preserving the competitiveness of the local and international market for all organizations [7]. It is applicable in various sectors of Business, Finance, Agriculture, Education, ICT, fashion, real-estate, media entertainment, logistics services and insurance etc.

### 3.1 Digital resources

Digital Resources represent a firm's ownership and control of assets and capabilities. The assets represent the enterprise resource from physical and intellectual view, while the capabilities usually focus in human, information, or organizational capital. Merging the resources together enable successful deployment. In pursuit of DT, the firm's re-define the way it creates and delivers value to customers by acquiring or developing new digital assets and capabilities. The most essential digital assets and capabilities needed for digital change includes digital assets, digital agility, digital networking capability and big data analytics capability [16].

#### 3.2 Organizational structure

Apart from the digital resources needed to achieve DT, a key issue to consider is the organizational changes needed to adapt to digital change [18]. It specially regards to organizational structure that is flexible, and composed of separate business units, digital functional areas with agile organizational set up.

- Expectable costs: cloud services are typically paid on a monthly basis or based on use with little or no upfront costs, thereby predicting the cost of services as expected.
- Reduced total cost: benefits of cloud services derived from economies of scale that a service provider can achieve.
- c. Access to the best and best technology: cloud services enable organizations to benefit from the best and latest technologies, without making any initial costs.
- d. Pay per use: in the model of cloud services, organizations pay for actual rather than maximum use.

It is predicted that by 2025 all ICT business solutions will be realized in a cloud, which means they will use cloud technology and cloud models. More than 85% of corporate applications will be located directly in the cloud [7].

# 4.2 Mobile technology:

Mobile technologies realize the goal of DT in SME's. It provides a seamless interaction between the customers at all touch points with businesses. The growth of a mobile digital business platform is primarily based on smartphones or tablets development that transform society and the global economy. The use of Mobile technologies improves productivity, portability, and work mobility. These further the integration and digital collaborations that provide profitto SME's.

## 4.3 The Internet of things (IoT):

This is the internetworking of physical devices, vehicles (also referred to as "connected devices" and "smart devices"), buildings, and other items. It is embedded with electronics, software, sensors, actuators, and network connectivity that enable these objects to collect and exchange data. The Global Standards Initiative on Internet of Things (IoTGSI) defined the IoT as "the infrastructure of the information society." IoT's in SME's allows objects to be sensed or controlled remotely across existing network infrastructure. It creates opportunities for more direct integration of the physical world into computer-based systems, and results to improved efficiency, accuracy and economic benefit in addition to less human intervention.

#### 4.4 Bigdata and data analytics

The volume of business data is increasing by seconds, such data requires a medium of manage and analysis to extract insight. As a challenge, it's no longer efficient for data warehouses (DWs) to manage heterogeneous information loads. Therefore, pooling data resources in a cloud model allows for greater flexibility and faster innovation for dynamic business demand. Cloud computing has changed the parameters that have enforced the traditional relational database restrictions because it delivers dynamic resource allocation, virtualization, and dramatic economies of scale for managing large amounts of data. SME's fully extracts business insights from Business Intelligence (BI) tools like Google BigQuery web service for big data and Google CloudSQL for relational database.

#### 4.5 Al and ML algorithms

Artificial Intelligence in the form of bots or Machine Learning algorithms come into play as information analysers and advisers in finance, health, recruiting, fast-moving consumer goods, logistics, insurance, land registration in government and agriculture with the intent of aggregating and making sense of big data repositories to introduce market efficiencies [19].

# 5. Barrier and key drivers for SME's DT in Nigeria

The main difficulties and obstacles to the digitization of SME's in Nigeria are not only technologies. The barriers and critical influencing factors which affect DT were identified through thematic analysis and categorized into technology, organizational and environmental factors presented as ten critical influencing factors [20].

#### 5.1 Digital technology adoption costs

The deployment of DT infrastructures requires the deployment of new technologies and systems in organizations. An initial cost will be attached: which could include staffing cost, the cost of software, cost of hardware devices and general operational and maintenance costs. In the SBEs study, the average initial costs in the adoption phase were about 0.9m naira [20]. This constitutes a

sizeable investment that could deter a lot of SME's in Nigeria from embarking on DT initiatives.

### 5.2 Information technology skills/expertise

The deployment of Digital technologies requires specialist with IT skills, which are rarely present in Nigeria SME's. For any SME to effectively embark on DT initiatives, it will require professional third-party IT expertise. Most of the company staff will also need to be proficient in the use of IT resources and this is problematic in many Nigerian SMEs, where 90% of staff are semi-skilled and have little or no IT skills or experience.

#### 5.3 Perceived benefits

With the limited resources in SME's it becomes difficult to adequately utilize those resources in areas where the business expects value to be delivered. There must be clear perceived benefit for it to be worth investing for SMEs to embark on DT initiatives.

#### 5.4 Technology adoption

There is need for internet to be suitably available at the business premise: office and work locations at a suitable cost/rate. This remains one of the critical issues affecting DT in Nigerian businesses. A tight cost control of internet services is often of paramount importance; internet costs are particularly relevant in an SME environment.

#### 5.7 Evolution of customer/consumer needs

Many SME's that engage in DT initiatives aim to improve customer experience, digitalize services and products. Customer and consumer views are essential to most aspects of SME operations, and in Nigeria they often influence the adoption and use of digital technology. The use of smartphones in by Nigerians is increasingly making users to expect delivery of digital services. Mobile-based

and web-based services are determined by focusing on retail sales in some industry sectors. The growing IT awareness and day-to-day familiarity with digital devices of a company's customers need is driving the adoption of digital technologies in SMEs in Nigeria.

#### 5.8 Government policies and regulations

The government policies regarding the adoption of digital technologies by SMEs in Nigeria are at it infants stage with less motivations. The move to digitally transform SMEs in Nigeria could be promoted and advanced through Government interventions, subsidies for appropriate technology investment, and support for skills development. Government agencies and ministries should digitally transform its functions to set examples as enablers to the SME's.

#### 5.9 Trust/ security concern

Trust and Security concern are vital issues affecting DT in Nigerian SMEs. These issues can be seen as a multifaceted factor as it relates to staff trust, security and confidence in the digital technologies being use in the company. The customer/consumer trust in online payment systems, online purchases, and the technology regulatory environment security is relatively low.

#### 5.10 Power availability

The availability of Power is paramount amongst the key issues influencing DT in Nigerian SMEs. On average, Nigerian businesses lose about 10 hours a week as a result of power loss [20]. This has a significant impact on businesses reliant on digital technologies and IT systems, making it very difficult to work productively in these periods. Many companies have sought alternative sources of power, such as the use of generators, solar panels and inverters which hinders DT progress in the SME's sector.

#### 6. DT implementation in Nigerian SME's

To remain relevant and competitive in Nigeria economy today, an SME must embrace a DT strategy. The advantage of implementing the appropriate technologies in SMEs will enhance overall performance as twice as digital laggards [6]. To be successful, DT does not have to be complicated but rather concentrate on projects with the highest return on investment. According to Azevedo and Almeida [21], a DT expert opines three critical factors for every successful DT, this includes Strategy and mindset, skill and technology of which must have a perfect balance to achieve the success. To implement the strategies there is need to adhere to the following issues with regards to any SME development in Nigeria.

#### 6.1 Organizational change management plan

To implement a successful organisation, change management, organizations should apply diverse strategies and actions. And should include Plans in prioritizing the strategies accordingly, emanate transformation from Top management levels, provide a roadmap to help employees to understand the aim of the

organizational interest, monitor and measure in order to evaluate the entire process continuously.

#### 6.2 Up-skilling and recruitment of expertise:

The shortage or lack of expertise should be understood and devise means of investing in to human resources that make use of Digital resources. Further more employees should be trained to use new tools and adopt new trends for development. A key to digital success of organizations' is to begin the change with humans and not technology by involving the whole team from the beginning to the end.

#### 6.3 Meeting customers need:

In order to meet customer's expectation and needs, organization should be updated with new trends, methods and technologies to enhance their experience.

#### 6.4 Digital transformation security:

All security controls and policies should continuously be reviewed to preserve the integrity, confidentiality and availability of resources. Implement risk management techniques to safe guide the use of technology by users.

# 6.5 Digital transformation budget planning:

Organizations should imbibe a financial roadmap to facilitate the transformation process with priorities, timeline and plans. It should be prepared based on overall aim and should be flexible to accommodate future challenges.

#### 6.6 Government intervention:

The government should improvise more soft policies with supportive environments for SME's in Nigeria. It should provide incentives to invest in the vast technology that would be of benefit. It would further encourage incountry production of appropriate hardware and software systems for utilization.

#### 7. Conclusion

SMEs in Nigeria are looking for a good business environment that does not negatively affect corporate flexibility. One of the key success factors in the global business environment is for any company to be able to adapt quickly and effectively to changes.
